Minutes of UUFSD Board Meeting Tuesday, June 14, 2016, 7:00 pm – 9:10 pm Minister's Office, UUFSD

Board Members present: Alisa Guralnick, President

Alisa convened the meeting at 7:00 pm, Glen read opening words, and members checked-in and remembered the victims of the Orlando nightclub shooting.

NEW ACTION ITEMS

-Board Retreat in August. **All Board members and attendees** should plan to attend the kick-off Board retreat on Sunday, August 21 from 12:00 to 5:00 pm at Mark Tuller's house. **Alisa and Mark** to plan and to circulate agenda.

-July Board meeting. No meeting of the Board in July.

-Calendaring meeting in August. **Alisa and Mark and Rev. Meghan** to attend calendaring meeting on August 14. All others welcome of course.

-*Congregational Meeting.* **Alisa** and various others to complete preparations and prepare for possible contingencies (quorum, floor nominations, etc.) DONE—meeting went well in terms of budget adoption and elections of Board members, officers, and Search Committee; not so well in terms of time and parliamentary order.

-Check signing authorizations. **Alisa and Mark** with **Glen's** help need to go to Wells Fargo and do what needs to be done to become authorized signatories as voted by the Board.

-*Handicapped parking spaces.* The sense of the Board (no vote taken) is that at least one more handicapped space should be painted onto the parking lot, given that at least one member has been unable to attend occasionally because the existing spaces are in use. **Alisa** to contact Ken Schultz of Buildings & Grounds to get it done.

-Key. **Alison S.** authorized by Rev. Meghan to have a key and should get it from Tracey. [There are many keys floating around. When does the proliferation become a security issue such that we should re-key the locks and start over?]

-*General Assembly delegates.* The sense of the Board was that no process or attention is focused on selecting or supporting UUFSD members wishing to be delegates to GA. **Alison S.** to take this on as a project.

OLD ACTION ITEMS

-Rev. Meghan's contract. Alisa and Meghan to complete.

-*Contribute button on website.* **Alison S.** to talk to didge and Adrienne. **Someone** needs to take this on as a project and push this to completion because we are losing contributions that could be ours.

DECISION ITEMS

Election of Interim Board member. Alisa reported that Ashley Phillips has resigned from the Board. Under the bylaws, the Board appoints an interim member until the next Congregational Meeting; the Nominations Committee having selected Heather Stroud to replace Ashley at the upcoming Congregational Meeting on June 19, Alisa proposed electing Heather as interim in the meantime. After discussion, the Board adopted the following resolutions:

RESOLUTION OF APPRECIATION TO ASHLEY PHILLIPS:

In appreciation of the service that **Ashley Phillips** has given to the Fellowship as a member of the Board and as Vice President, the Board of Directors upon motion made and duly seconded unanimously adopted the following resolution, June 14, 2016:

WHEREAS, Ashley Phillips accepted the leadership position of Vice President of the Fellowship and has devoted many hours of service to the Fellowship in that position and as a Board member; and

WHEREAS, the Fellowship could not function without the tireless efforts of volunteers such as Ashley; and

WHEREAS, Ashley Phillips has resigned as a Board member and as Vice President;

NOW THEREFORE BE IT:

RESOLVED, The Board accepts with regret **Ashley Phillips'** resignation as Vice President and member of the Board.

RESOLVED, The Board extends its profound thanks to her and hereby formally acknowledges the Fellowship's appreciation for her time, diligence, and effectiveness. Job well done!

RESOLVED, The President is requested, on behalf of the Board, to publicly acknowledge Ashley's contributions and to recognize her.

DECISION:

Upon motion made and duly seconded, the Board unanimously **ELECTED Heather Stroud** as a member of the Board of the Fellowship, to fill that position until the Congregational Meeting on June 19, 2016, at which time it is anticipated she will be elected to a one-year term to fulfill the remainder of Ashley Phillips' term, pursuant to the bylaws. **Board nomination of Search Committee.** Alisa presented the proposed slate for the Settled Minister Search Committee. Procedurally this is a nomination made by the Board to the Congregation, rather than by the Nominations Committee.

Contract for Rev. Meghan. The Board discussed the need to replace Rev. Meghan's existing interim minister contract with a consulting minister contract that would enable her to enter discussion about candidacy as settled minister, and at the same time extend her service for at least an additional year.

DECISION:

Upon motion made and duly seconded, the Board unanimously **AUTHORIZED Alisa Guralnick, as President,** to negotiate and sign on behalf of the Fellowship an appropriate consulting minister contract with Rev. Meghan Cefalu, to extend the term of her service and to replace the existing interim minister contract, effective August 1, 2016, at the salary included in the budget for fiscal year 2016-2017 as adopted by the Congregation.

Check signing authorization. In view of Ashley's resignation, and because the Finance Committee recommended additional signatories be authorized for convenience purposes, the Board considered who should be authorized to sign checks on behalf of the Fellowship.

Upon motion made and duly seconded, the Board unanimously **AUTHORIZED AND DELEGATED TO**

Alisa Guralnick (new authority) Mark Tuller (new authority) Glen Bowden (continuing authority) Steve Rosen (continuing authority) Robin Mitchell (continuing authority)

Caroline DeMar (continuing authority the authority to sign checks on behalf of the Fellowship in any account owned by the Fellowship; and **CANCELLED AND WITHDREW** the authority previously given to **Ashley Phillips** to sign checks; and **DELEGATED TO Glen Bowden**, *Treasurer*, and to the Finance Committee, the authority to implement the above as necessary, such as by signing forms and signature cards at financial institutions. **Adoption of Budget.** Glen presented the most recently revised budget for fiscal year 2016-2017, incorporating the decisions previously made by the Board (e.g., concerning UUA dues, staff salary raises, inclusion of Director of Connections, etc.).

DECISION:

Upon motion made and duly seconded, the Board unanimously **APPROVED THE BUDGET AND AUTHORIZED IT TO BE SUBMITTED TO THE CONGREGATION FOR ADOPTION** at the Congregational Meeting on June 19, 2016.

REPORTS, DISCUSSION ITEMS, AND INFORMATION ITEMS

Congregational Meeting preparation. The Board discussed preparations for the upcoming Congregational Meeting, including sequence, timing, speakers, how to present the salary increases, how to present the budget given the cuts to UUA dues and committee requests, etc.

Classrooms work. Clint reported that he is acting as project manager and that appropriate permitting from the city is anticipated (the fire department may have comments) and that the contractor can start soon on the lower two classrooms.

Environmental Justice Task Force. Alison Schlick as liaison to this group reported on efforts to restart the Green Sanctuary Program, which was attempted without success several years ago (see Policy 470, suspended in 2011). It involves education, campus sustainability, and other initiatives, and the group is looking to a possible Congregational vote next June.

Other. In no particular order: Rev. Meghan will be gone all of July and the first week of August. Chris Lehman, the new Music Director, will be coming on board before the end of June and will overlap a bit with Jill Reis. The rainbow flag evidencing us as a welcoming congregation is now flying. Now that Heather is on the Board she will be leaving the Personnel Committee, so that committee is down to one person. Team Genero\$ity has scheduled a calendar of fundraising events.

The President declared the meeting adjourned at 9:15 pm. The next scheduled Board meeting is the retreat on Sunday, August 21, from 12:00 to 5:00 pm at Mark Tuller's house.

Report to the Board of Directors Rev. Meghan Conrad Cefalu June 14, 2016

Hello friends,

This month I'm thinking more "big picture" about the Fellowship. So rather than list all that I'm engaged in in the last several weeks I wanted to bring a couple of areas to your attention.

One of my (and I'm sure your) ongoing frustrations is around the issue of **communications.** Members and friends do not seem to know what is going on in the life of the Fellowship though there are announcements from the pulpit, paper schedules handed out each Sunday, a bulletin board in the core area, a Happenings Table staffed after each service, a Facebook page, a Yahoo list, a weekly e-newsletter, email blasts, a quarterly newsletter and a website. When I return from my summer break I will be working with the Communications Committee along with Adrienne to see if we can figure out some more workable solutions.

I have been wondering why this congregation, though it is an officially designated Welcoming Congregation, does not display the **rainbow flag**. I mentioned it during the course of the New Member Orientation workshop a few weeks ago and the following day Irv sent out an email to some SAC folks suggesting we do so immediately. In light of Saturday night's massacre of 50+LGBT folks at the nightclub in Orlando I am hoping that happens quickly. Flying the flag is a clear symbol to LGBT-identified people that we are a congregation that welcomes them. As a queer person I can tell you that if an organization/business/church says it is "welcoming" but does not clearly display the rainbow symbol I am not certain if they really mean it. If this congregation desires to be a truly welcoming congregation we should make it more public.

After now attending a **Casas de Luz** home build I am even more puzzled about why some leaders of the fellowship decided to reduce the fundraising efforts of the project – essentially pushing CdL out of the congregation. Building a home in two days for a family in need is a phenomenal experience. Not only does it change one family's life forever giving their kids a fighting chance of staying in school and having a future, but it creates a sense of community among those building and across language barriers with the Mexican builders with whom we worked side-by-side. All of the participants were positively changed by the experience.

There are a number of other big-picture issues I'll be covering in Sunday's report to the congregation at the meeting. That's it for now. Thanks so much for your ongoing good, strong leadership. It is a joy to serve as your minister. ⁽²⁾

UUFSD TREASURER'S REPORT JUNE 19, 2016

As of May 31st there was an operating deficit of \$5,493. Pledge collection was at 93% of budget. If we can collect most of the remaining \$44,500 we will be close to breaking even for the year.

Cash assets total \$779,950. Almost all of this is committed to various non-budget funds and activities. These include:

The Spirit Grant for Adrienne McCord's activities. The original grant was for \$100,000 to cover three years. The remaining balance is \$77,196.

The Capital Campaign now has a balance of \$1,145,846. This includes \$607,088 in cash and \$538,758 in pledges.

Other carryover and reserve funds total \$65,784.

A note on the operations of Casas de Luz. The program took in a total of \$90,422 with \$77,394 in expenditures. In 2015, It was the 10 year anniversary of the first Casas de Luz home build. Using the church year we built 13 homes last year. Over 500 people participated in these builds. Some of the sponsors were Skyline School, YMCA trailblazers, individual families and even a high school from Oregon. In addition to home builds we have delivered over 75 truckloads of donations to both Tijuana and San Diego. We have also sponsored serving breakfast 5 days a week in our community center in Colonial Cumbres. The Cumbres community center has a new porch with a roof that has been a welcomed addition.
